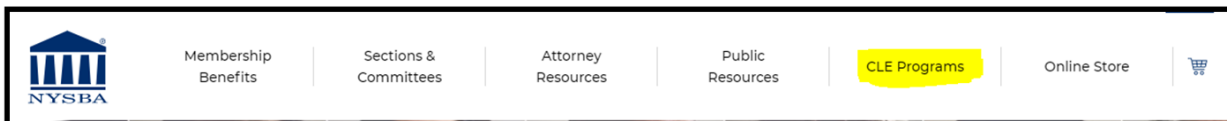


Once you're there, go to “Groups” and select “My Groups” and from there, you can go to the community groups of your sections:



## PURCHASING PROGRAMS:


When purchasing programs, go to CLE Programs and select if you want to register for a **live** program or an **on-demand** program (recordings).
